- (1) The MEMBER understands and acknowledges that any agreed upon pricing for products or services subsequent to this agreement will be governed by a master contract signed by the East Central BOCES and the successful vendor.
- (2) The MEMBER acknowledges that although some participating members of this consortium will receive e-rate discounting which may be applied to their individual bills, the MEMBER is not eligible for such discounts and will be responsible for full payment of any elected services they choose to purchase.
- (2) The signatory certifies that they are authorized to procure and/or order telecommunications and other requested services for the MEMBER covered by this Letter of Agency. The signatory certifies that they are authorized to make this request on the MEMBER's behalf, that I have examined this Letter, that all of the information on this Letter is true and correct to the best of their knowledge, that no kickbacks were paid or proposed with prospective vendors, and that false statements on this form can lead to ineligibility to participate in this consortium process in current or future funding years.
- (4) The MEMBER understands that all bids submitted will be carefully evaluated and the most cost-effective service offering will be selected by the consortium review committee, with price being single most heavily weighted factor.
- (5) The signatory certifies that they are authorized to sign this Letter of Agency and, to the best of their knowledge, information, and belief, all information provided to the ECBOCES or Colorado Education Broadband Coalition is true.
